

# Recreational Marine Driver / Personal Watercraft Licence Application

Transport Operations (Marine Safety) Regulation 2004

This form may be used to apply for:

- a Recreational Marine Driver licence;
- a Personal Watercraft (PWC) licence; or
- a Confirmation Report stating that you are the holder of a current Recreational Marine Driver and/or Personal Watercraft licence.

To apply for a Recreational Marine Driver licence, you **must** be at least sixteen (16) years of age or older and be able to produce evidence that you have:

- successfully completed a Queensland Transport approved course of instruction; or
- a current interstate recreational marine licence.

To apply for a Personal Watercraft licence, you **must** be at least sixteen (16) years of age or older, hold a valid marine licence and be able to produce evidence that you have:

- passed an examination in the approved form; or
- successfully completed a Queensland Transport approved course of instruction; or
- a current interstate Personal Watercraft licence that is recognised in Queensland.

## Evidence of identity requirements

You **must** give evidence of your identity at the time of making this application. If you do not have a **Queensland driver licence** (current or expired less than 2 years), you must show at least **three (3)** evidence of identity documents.

These documents must include at least one **Category A** and at least one **Category B** document. The third document may be from either category, however, one of these documents must include your signature.

If you have changed your name or the details of your name are different on the documents provided, you **must** provide evidence of the name change from the relevant Registrar of Births, Deaths and Marriages.

**Each document must be an original document.**

**Evidence of identity documents** include:

### Category A

- Australian Birth Certificate (full)
- Australian Passport (current or expired less than 2 years)
- Foreign Passport (current or expired less than 2 years)
- Queensland Card 18+ (issued after 01/01/92)
- Australian Citizenship or Naturalisation Certificate
- Australian photo driver licence (current or expired less than 2 years)

### Category B

- Medicare card
- Financial institution debit/credit card (must include signature and embossed name)
- Education institution student identity document (must include photo and/or signature)
- Dept of Veterans' Affairs/Centrelink Pensioner Concession card includes Health Care Cards
