# Queensland Regulated Ship Census, June 2017

## About this publication

This publication presents the results of a census taken of Queensland regulated ships that were registered on 30 June 2017. Queensland regulated ships are recreational vessels or other vessels expressly excluded from the operation of the *Marine Safety (Domestic Commercial Vessels) National Law Act 2012 (Cth)* or the *Navigation Act 2012 (Cth)*.

The data presented in this publication was extracted from the Department of Transport and Main Roads TRAILS Registration System (the register) on 6 July 2017.


Tables of statistics are included which give selected details of the ships. These include the maritime region in which the ships were registered, the length of the ship, the ship types, the engine output, the year of manufacture, the method of storage and the age, gender and licence status of those who have registered the ships.

For purposes of comparison, data is also provided at 30 June for the years 2012 and 2016.

The calculation of the growth rates and decommissioning rates mentioned in this report have been made using the formulas described in the Australian Bureau of Statistics 9309.0 - Motor Vehicle Census, Australia using data presented in the attached tables and previous additions of this report.

## **Key Points**

At 30 June 2017 there were 258,340 Regulated Ships (boats and personal water craft) listed on the register by 222,718 different registrants (individuals or organisations). This equates to approximately one registered Regulated Ship for every 19 people resident in Queensland.



Number of registrants registering a particular number of boats

There were 233,438 boats registered by 205,244 registrants. The majority of registrants (88.2%) had registered a single boat while another 10.4% of registrants had registered two boats. The remaining 1.4% of registrants had registered a total of 4.1% of all registered boats (9699). While the majority of boats (229,660) were registered by individuals, 3760 boats were registered by 2451 organisations.


There were also 24,902 PWC registered to 22,338 registrants. The majority of registrants (90.6%) had registered a single PWC while another 8.3% of registrants had registered two PWC. The remaining 1% of registrants had registered a total of 3.8% of all registered PWC (935). While the majority of PWC (24,162) were registered by individuals, 740 PWC were registered by 426 organisations.

It is of interest to note that 4864 registrants had registered at least one boat and at least one PWC. In total these registrants registered 6269 boats and 5833 PWC. The majority (68.7%) registered a single boat and a single PWC.

During the twelve months ending 30 June 2017, 17,775 boat registrations were added to the register, 17,054 were removed from the register, while 19,694 were transferred from one registrant to another. Based on these figures Queensland's flotilla of registered boats has a decommissioning rate of approximately 6.8% per annum.

Over this same period 3637 PWC registrations were added to the register, 2168 were removed from the register while 3086 were transferred from one registrant to another. Based on these figures Queensland's flotilla of registered PWC has a decommissioning rate of approximately 8% per annum.

Together these transactions resulted in the number of boats and PWC on the register increasing by 0.31% and 6.26% over the past year and by an annual average rate of 0.85% and 7.4% over the past five years respectively.

At 30 June 2017 72% (161,162) of the 223,808 boats registered on 30 June 2012 remained on the registry of these, 161,008 were registered in the June of each of the years 2012 to 2017. Likewise at 30 June 2017 61% (10,686) of the 17,398 PWC registered on 30 June 2012 remained on the registry of these, 10,668 were registered in the June of each of the years 2012 to 2017.



The most popular type of boat is the open runabout which accounts for 66% (154,140) of the boat flotilla. Almost all of these boats (91%, 141,373) are trailered rather than moored or otherwise accommodated.

Fifty per cent of open runabouts are: no longer than 4 metres, have engines producing no more than 22 kilowatts, were manufactured more than 13 years ago. The median age of the registrant of these boat was 54 years. Nine per cent (13,960) of open runabout fall within all four of these limits.


Generally the majority of boats (71.2%) are no more than 5 metres in length. This percentage increases to 96.6% for boats which are no more than 10 metres in length.



Nevertheless the extant records indicate that 25% of boats were manufactured before 1996, 55% were manufactured between 1996 and 2010 leaving 20% that were manufactured within the last 7 years. The average age of a boat is 16.9 years and the median age is 13 years.


In contrast only 0.63% of PWC have been registered without the year of manufacture being recorded.

The majority of PWC (64%) were manufactured between 2006 and 2015 while 25% of PWC were manufactured before 2005 when PWCL were first introduced. The average age of a PWC is 7.8 years and the median age is 7 years.




Fifty per cent of boats are fitted with an engine producing no more than 30 kilowatts while 90% of boats are fitted with engines producing no more than 145 kilowatts.

Estimating the age of the flotilla presents some difficulty as 20% of boats were registered without the year of manufacture being recorded.







Baby Boomers (people born between 1947 and 1966) registered 44.5% of the boats and 31% of the PWC on the register. Generation X/Y (people born between 1967 and 1986) registered 36.2% of the boats and 49.5% of the PWC.

The average ages of those registering a boat or a PWC were 53 years and 45 years respectively. Males registered 89% of the boats and 85% of the PWC on the register.

Thirteen per cent of boats have been registered by a registrant who does not hold a Recreational Marine Driver Licence (RMDL). Fortysix per cent of registrants obtained their RMDL no later than the year 2000 while 42.4% obtained their RMDL between 2001 and 2017.

Twelve per cent of PWC have been registered by a registrant who does not hold a Personal Water Craft Licence (PWCL). Sixteen per cent were issued a PWCL in 2005, the first year in which PWCL were issued, while 54% were issued a PWCL between 2011 and 2017.
